SkyWater was formed in 2017 with private equity backing from Oxbow Industries to purchase Cypress Semiconductor's 200 mm fab in Bloomington, Minnesota. In January 2021 SkyWater announced its new advanced packaging facility in Kissimmee, Florida. In April of that same year, SkyWater completed an initial public offering (NASDAQ: SKYT).

**Facilities** 

SkyWater's Minnesota facility (SWMN) manufactures 200 mm wafers in its 91,000 ft<sup>2</sup> of cleanroom space. In October of 2020, an expansion funded by the DOD was completed which added tooling to support Cu interconnect processing and increase throughput. The SkyWater facility is certified to ISO Quality Standards for Automotive, Medical and Environmental.

In January 2021, SkyWater took over operations at the Center for Neovation in Kissimmee, Florida (SWFL), to provide heterogeneous integration services. That facility offers 35,000 ft² of clean room space. SkyWater partners with BRIDG, a non-profit organization created to focus on advanced research, development, and manufacturing for next generation microelectronics.
